## Narrative

### Patrol

- After eleven months, two MPD Officers who were hired in March 2019 have completed the academy and their Field Training Officer program and are now – “street-ready” solo-patrol officers.
- An MPD Officer observed a subject riding a bike similar to one that was reported stolen. The officer stopped the subject and the bike was positively identified as the one which was stolen. The officer arrested the subject.
- Monterey Police Officers, CAT, and MDOT responded to a domestic disturbance with an attempted suicide. The officers utilized their Integrating Communications, Assessment, and Tactics (ICAT) training to remove the children from the second story of the home and render aid. MDOT and Monterey officers provided resources and emotional support following the incident.

### Investigations

- Investigations implemented a Detective Mentorship Program (DMP) in February. The DMP consists of patrol officers temporarily assigned to Investigations for approximately one month. DMP detectives learn investigator work and responsibilities firsthand. They review reports, conduct follow-up, write search warrants, develop plans, lead briefings and assist patrol with in-progress calls.

### Community Action Team (CAT)

- CAT abated (55) encampments. Twenty-two of those were at Windows on the Bay Park. Flyers with information regarding services available to the homeless were provided.
- CAT officers held ‘Coffee with a Cop’ at Starbucks on Lighthouse Avenue.

- Community Services Officers spoke at a community meeting regarding raccoons.
- A CAT officer attended a Teens Addiction presentation in Carmel.
- A CAT officer spoke at a Skyline Ridge Estates community meeting.

### Monterey School Resource Officer (SRO)

- The School Resource Officer took part in a presentation with the CHOMP Emergency Room Director at Monterey High School. The presentation depicted real life stories of drug overdoses with the hope of reducing teen drug use and encouraging the youth to call for assistance in the event of a drug overdose occurring in their presence.
- The SRO visited a kindergarten class at Foothill Elementary School. The SRO talked to the students about a career in policing and ways police help people.
- The SRO and a CAT officer conducted a presentation to preschool children at La Mesa Elementary School. The children asked questions and explored a patrol vehicle.

### Multi-Disciplinary Outreach Team (MDOT)

- MDOT assisted a homeless female at the Transit Plaza and arranged for transportation so she could pick up medication at the CHOMP mobile clinic.
- MDOT assisted a homeless male with clothing.
- MDOT transported a homeless male to the Second Chance thrift store so he could apply for the Bridge Restoration Ministry Program in Pacific Grove.
- MDOT assisted a Domestic Violence victim with obtaining rent assistance for February and March.






Table A – February 2019 v. February 2020




Table B – 2019 Monthly Average v. February 2020
