JANUARY 2022



Patrol

- 01-05-2022- MPD responded to a vehicle that had collided into an electricity pole causing the pole to break at its base. A portion of the city lost electricity and the street was closed for several hours.
- 01-08-2022- MPD responded to a domestic dispute in Monterey. Officers contacted the male subject involved, and the subject provided officers with a false name. Officers discovered the subject was in possession of a stolen e-bicycle and had an outstanding felony warrant. The suspect attempted to flee during his arrest, however officers were able to successfully take him into custody.
- 1-19-2022- Officers arrested a high school student for fighting on high school grounds after the suspect and his friends battered another student.
- 01-21-2022- MPD responded to a single vehicle collision. The driver was not wearing his seatbelt and impacted the windshield. The driver was transported to Natividad Medical Center for medical treatment.
- 01-24-2022- MPD officers arrested a suspect for grand theft after the suspect conducted a snatch-and-grab theft of a necklace from a victim's neck.
- 01-27-2022- MPD officers arrested a driver for driving under the influence in Monterey. Officers learned that the driver and vehicle were also involved in a hit and run collision in Pacific Grove.
- 01-28-2022- Officers arrested a subject for possession of drug paraphernalia and a controlled substance.
- 01-28-2022- Officers responded to a suspicious vehicle driving recklessly. Officers identified the two male occupants of the vehicle and discovered they both had outstanding warrants. The suspects fled from the officers and after a pursuit of the suspects, officers arrested them and booked them at Monterey County Jail.

- 01-28-2022- Officers responded to a report of an armed suspect brandishing a firearm. Officers arrived on scene and located the suspect. The suspect was found in possession of an imitation firearm. Officers arrested the suspect for displaying an imitation firearm and transported the suspect to Monterey City Jail.
- 01-30-2022- MPD investigated a suspicious death at a Monterey Motel. The investigation is ongoing.

Narcan Administered Lifesaving

 MPD responded to a 46-year-old male who overdosed on opiates. Monterey Fire Department administered one dose of Narcan. AMR transported the subject to CHOMP.





Community Action Team (CAT)

- Encampment Noticing & Abatement
 - Noticed (42) encampments
 - (51) at Del Monte Beach; (21) at Window on the Bay; (4) at the Transit Plaza; (2) at Dunes Area/ Del Monte Beach; (2) Recreation Trail/ North of Drake Avenue; (1) at Old Capital Site; (2) at 68/ Garden Road' (1) Hwy 1/ NB Fremont Underpass (Cal Trans); (3) Aguajito/ 3rd; (1) Del Monty/ Hwy 1 off-ramp; (1) 605 Lighthouse; (1) Hwy 1/ Casa Verde' (4) Recreation Trail/ La Playa; (5) Robert's Lake; (4) Don Dahvee Park; (2) Del Monte/ English; (1) Franklin/ Figueroa;
 - Officers provided flyers to homeless persons with information regarding services available to them.
- CAT conducted compliance checks for human trafficking signage in 88 businesses in coordination with the Monterey County District Attorney's Office.
- CAT conducted a massage parlor inspection and issued citations.
- CAT participated in the Point in Time homeless census count in conjunction with several non-governmental organizations.
- CAT patrolled the Old Capital Site and Ford Ord Property on three separate occasions.
- CAT coordinated with Cal-Trans and CHP on unsheltered encampments on state property.

Multidisciplinary Outreach Team (MDOT)

- CAT/ MDOT collaborated to help a subject obtain airfare to Missouri where the subject will begin treatment for substance abuse.
- CAT/ MDOT collaborated to provide services, gift cards, and a temporary cell phone to a victim of domestic violence.
- CAT transported an adult male to Sun Street Center for inpatient treatment of substance abuse.
- CAT/MDOT has been working with an adult female for several months with options for substance abuse treatment. The subject called to inform CAT that she was entering into the Sun Street Center facility.
- CAT transported an adult male to CHOMP for detoxification before beginning the Bridge rehabilitation program.
- CAT/ MDOT assisted a mother and her daughter with resources for substance abuse. A doctor from CHOMP responded to MPD to speak to the parent and child for help with her substance abuse addiction.
- MDOT/ Interim assisted an unhoused male with temporary housing at a motel and scheduled an assessment so he can enter their program.





Case Study - John Doe 0122 (January 2022)

In an effort to explain some of the challenges faced by the MPD in trying to problem solve through a variety of ways, these case studies highlight aspects that the MPD and partners in MDOT face while attempting to resolve issues. This month's case study provides another challenging example.

- John Doe 0122 is a 64-years old local unhoused individual. He has been contacted by the Monterey Police Department approximately 982 times over the last twenty years primarily for being a habitual drunkard, probation violations, and City of Monterey Ordinance violations.
- John Doe 0122 has repeatedly been offered MDOT services and resources in an attempt to assist him with his alcohol addiction and homelessness. The MPD/MDOT have provided the following to John Doe 0122: senior housing assistance, Adult Protective Services, obtaining social security cards, transportation to rehabilitation with Sun Street Center, completing paper work with assessment and eligibility information for traditional housing, transportation to sobering centers, transportation to intake meetings and rehabilitation programs and transportation to CHOMP for detoxification and rehabilitation. John Doe 0122 only shows interest in programs when the weather becomes cold or when there are multiple enforcement contacts resulting in citations.
- John Doe 0122 has thirteen active criminal cases pending. Those pending cases include trespassing, open alcohol/consumption and Monterey City Code violations. Doe 0122 has had approximately twenty-one cases, which were sent to the revenue/collections division that have not been paid.

The following timeline demonstrates interactions with John Doe 0122 over the last two years, from January 2020 to February 2022: 01-2020 - offered senior housing, advised MPD working with APS; 01-2020 - contacted with Adult Protective Services and Montage social worker, refused process; 05-2020 - admitted to Sun Street rehabilitation program; 07-2020 - MPD completed paperwork for transitional housing and eligibility; 01-2021 declined MDOT services, warned about MCC Code violations; 01-2021 - MPD provided transportation to sobering center after obtaining medical clearance; 02-2021 - declined services, arrested for trespassing at CHOMP; 02-2021 declined Sun Street and warming shelter; 2-2021 - declined sober and housing services; 02-2021 declined MDOT services; 05-2021 - contacted and asked for ambulance, but declined other services; 05-2021 - placed on self-committal, requests rehabilitation; 05-2021 _ provided Bridge application and assisted in turning paperwork in; 06-2021 - transported to Bridge meeting for detoxification; 06-2021 - transported to Sun Street; 11-2021 - declined MDOT services; 12-2021 - asked for rehabilitation at Sun Street and assisted with phone assessment; 12-2021 - asked for shelter assistance at Victory outreach, no beds available; 12-2021 - offered to transport to shelter, declined; 12-2021 - refused to go to shelter, given camp abatement; 12-2021 - complained of cold and rain but declined hotel and other resources; 02-2022 - programs advise MPD/MDOT that John Doe 0122 is no longer eligible for detoxification bed.

Investigations / Monterey Police Anti-Crime Team (IMPACT)

- 01-13-2022- Detectives assisted with the searching for an locating a runaway juvenile.
- 01-15-2022- Detectives assisted with numerous identity theft investigations in which the suspects possessed stolen mail, identification cards, and controlled substances.
- 01-21-2022- Detectives devoted a significant amount of resources to investigating a suspicious death.
- 01-23-2022- Detectives conducting surveillance arrested three suspects for possession of controlled substances and outstanding warrants.





Table A- January 2021 v. January 2022




Table B- Monthly Average v. January 2022
